2027 Community Health Improvement Grants Program

The CHI Health Community Health Improvement Grants Program is funded by contributions from our member hospitals. In awarding community grants, CHI Health actively partners with non-profit organizations working to improve health and quality of life in the communities we serve.

Grant funds are used to deliver direct services, strengthen care coordination and improve the health and well-being of underserved populations. The program is one way CHI Health puts its mission and values into practice by investing in programs and partnerships addressing priority community health needs (identified in the most recent community health needs assessment).



What you need to Know.

- The application period for 2027 grants is July 20- September 18, 2026.
- Applicants must be a 501(c)3 nonprofit or have a fiscal agent that is.
- Applications must address one or more significant health needs in the hospital's most recent community health needs assessment (CHNA) or implementation strategy.
- Applications are for one year of funding, beginning April 2027.
- Current and past Community Health Improvement Grant awardees are eligible to re-apply for funding, pending they are in good standing.

- Grants are based on hospital size (operating budget). Small grants are under \$20k and large grants are \$20k+.
- Large grants require identified collaborating partners and both a midyear and year end report from grantees. Small grant awards require a year end report only.
